ILO Labor Force Concept of "economically active population"


"... comprises all persons of either sex who furnish the supply of labour for the production of economic goods and services as defined by the United Nations systems of national accounts and balances during a specified time-reference period. ... includes all production and processing of primary products whether for the market for barter or for own consumption, the production of all other goods and services for the market and, ..., the corresponding production for own consumption."



11. Are you currently ...

- 1 employed full time with a weekly working time of 35 hours or more
- 2 employed part time with a weekly working time of 17 to 34 hours
- 3 employed part time or on an hourly basis with a weekly working time of less than 17 hours or
- 4 not employed
- 97 refused / 98 don't know

INTERVIEWER: 'Employed' refers to work for pay (wage, salary, fee), profit (in the case of self-employed persons), or family gain (in the case of contributing family workers)

Filter:

if code 1 or 2 go to question 14 if code 3 or 4 go to question 12 if code 97 or 98 go to question 22 In question 12, unemployed and part time employed people report their current situation on the labor market

In question 13, we asked unemployed, if they can start work on an offered job within two weeks

Question 14 reports the status on the labor market for part time employed respondents, the volume, the number of jobs and the homogeneity of job activities Question 15, all employed give the volume of their occupational activities

Question 16, not (or not longer) employed decide between full or part time former occupation

Question 17 codes the ISCO for all respondent actually or formerly occupational active.

Question 18 surveys for various groups the information necessary to detect the job autonomy

Questions 19 to 21 are asked if the contacted respondent is not the main income earner of the household; the ISCO code and the job autonomy are surveyed

Question 22 collects information necessary to identify the ILO concept of the economically active population and its working status

To all respondents

Only if question 19 = code 2 (transitional phrase): Now let's talk about you again.

22. Did you do any work for pay, profit or family gain for at least one hour during the last week (as an employee, a self-employed person, or as a contributing family worker)?

Filter:

if code 1 or 97 or 98 go to question 23 if code 2 go to question 22.1

- 22.1 What is the main reason why you didn't work (at all) last week? INTERVIEWER: Assign spontaneous response to a category if necessary read out the categories.
 - 01 short time working for technical or economic reasons
 - 02 labour dispute, strike
 - 03 school or vocational education, or further training
 - 04 sickness, accident or temporary incapacity to work
 - 05 maternity leave
 - 06 parental leave
 - 07 vacation
 - 08 compensatory leave (in lieu of overtime pay or within the framework of a working time account)
 - 09 personal or family reasons, child care, caring for household members or family members, sabbatical
 - 10 bad weather
 - 11 other reasons
 - 97 refused / 98 don't know

Conclusion

- The ILO concept is developed to detect the productivity of a national economy. Therefore all, even marginal employed people are included.
- A sociological concept has to separate respondents with an extent of work that defines social status and the derived prestige. This means that marginal employed and not working interviewees are filtered out, because their status and prestige are not determined by the labor force activity.
- The ILO concept is meaningless in social structure analysis, even if we gain the comparability with official statistics like the national accounts as references.

Conclusion -2-

- Our proposed module uses 9 questions for full-time and part-time employed survey partizipants and 8 questions for marginal and not employed respondents. The survey burden is limited to a minimum of questions.
- The three questions about the occupational activity coded with ISCO allow the link to SIOPS, ISEI and EGP.
