Vladimir Andreenkov is Director of the Institute or Comparative Social Research is the Russian organization participating in the European Social Survey. From 1979-1999 he was Head of the Survey Methodology Department of the Institute of Sociology (IS) of the Academy of Sciences and of the Institute of Social and Political Research of the Academy of Sciences of the Russian Federation, Dr. Adreenkov was awarded a Ph.D. in Sociology at the Institute of Sociology, Academy of Sciences of the USSR in 1985. He has long-standing experience in cross-national survey research and has researched and published extensively in social values, attitudinal and behavioral research and longitudinal change in attitudes, values, and time use. Recent publications include the *Handbook* of Sociologists. Moscow, 2005, 1988, 1983 /Russian/ (with G. Osipov et al.).

**Dorothée Behr** joined ZUMA as a researcher at the European Centre for Comparative Surveys, ZUMA in January 2006. She graduated in Translation Studies (English and French) from the University of Heidelberg in 2005. At ZUMA her work focuses on translation and translation assessment in the ESS context. She is also working on a doctorate on translation and quality management in comparative survey research.

Annelies Blom came to ZUMA as a researcher at the Center for Comparative Surveys in November 2005. She is a member of the ESS Central Co-ordination Team and works on contract monitoring and translations. Previously, she worked at the National Centre for Social Research (NatCen) in London. Ms. Blom holds an MPhil in European Politics from Oxford University and a BA in Social Sciences from University College Utrecht. She is currently working on a PhD on non-response bias in cross-national surveys.

Laura Branden is a Senior Study Director at Westat in Rockville, Maryland with extensive experience managing various aspects of data collection for large computer-assisted in-person and telephone surveys. She is currently the associate project director for the National Home Health and Hospice Survey and the National Home Health Aide Survey. She directed the National Nursing Assistant Survey which was part of the National Nursing Home Survey. She also directed the Early Childhood Longitudinal Study, Birth Cohort Child Care Provider (CCP) CATI survey. Before joining Westat in 1990, she was the data archivist for the National Longitudinal Surveys of Youth (NLSY-79). Her research interests are in survey methodology.

Michael Braun is a Senior Methods Consultant at ZUMA and directs the German General Social Survey (ALLBUS). He holds a habilitation from the University of Mannheim. Dr. Braun has specialised in cross-cultural survey methodology and analysis. He has played a major role in a number of ISSP questionnaire drafting groups (the multicountry groups responsible for designing and testing ISSP source questionnaires). He is involved in the ISSP methodology dealing with intercultural comparability of the standard demography. His main research interest lies in the relation between question design. translation, and data analysis. In particular, he is concerned with the use of dataanalytic methods to check the adequacy of translations. He also coordinates the national part of the EU-funded fivecountry study PIONEUR (Pioneers of Europe's Integration from "Below"). His most recent publications cover different kinds of errors in comparative surveys. Rachel Caspar is a Senior Survey Methodologist at RTI International. Ms. Caspar specializes in designing questionnaires and developing data collection procedures for surveys of sensitive topics. Her research interests include methods for adapting complex material and concepts to be easily and understood consistently by survey participants of all ages, educational, cultural and linguistic backgrounds, as well as methods for testing questionnaires. Ms. Caspar regularly teaches courses in questionnaire design and cognitive laboratory testing methods, most recently through the Joint Program in Survey Methodology, the Odum Institute at the University of North Carolina, and the Summer Institute at the University of Michigan. Karl Dinkelmann is Business Systems Analyst at the University of Michigan's, Institute for Social Research (ISR), Survey Research Centers (SRC). Karl spent 5 years as the Senior Programmer Analyst and technical advisor for the developmental activities of the World Mental Health (WMH) Surveys Initiative. The WMH Surveys Initiative is crossnational epidemiological mental health

research project involving 28 participating countries. The survey questionnaire marks the first major revision to the World Health Organization's (WHO) Composite International Diagnostic Interview (CIDI) since 1995. The unique nature of the CIDI is its capability of assessing mental disorders diagnostic criterion for the two different systems most widely used in world: the Diagnostic and Statistical Manual (DSM-IV) and the International Classification of Disease (ICD-10).

Karl is also a member of the Data Documentation Initiative - Instrument Documentation (DDI-ID) Working Group, a group charged with producing a data model that will allow data collection instruments to be documented within the DDI context (in the forthcoming DDI version 3.0). In addition, to the DDI-ID group he has also been working to identify survey lifecycle elements (particular from the data collection perspective) that have not typically been part of the DDI specification (with hopes of having an expanded set of these elements incorporated in DDI version 3.1).

Lauren Doerr is a Survey Director at the National Opinion Research Center at the University of Chicago (NORC). She has played a central role in developing and implementing interpretation and translation procedures for multilingual surveys at NORC, including the New Immigrant Survey and the Refugee Assistance Survey. **Brad Edwards** is a Westat Vice President Area Director with extensive and experience large-scale in survey management and design. Cross cultural comparability is also a focus of her research as surveys in the US, including CAHPS, are now often fielded in multiple languages. Patricia Goerman is a Postdoctoral Research Fellow in the Statistical Research Division at the United States Census Bureau. Her current research focuses on the development and pretesting of multilingual survey instruments with a focus on Spanish language materials. She received her Ph.D. in Sociology from the University of Virginia in 2004. Her dissertation is a study of Latino immigrants settling in nontraditional areas in the Southeastern United States. Her past research has included in-depth interviews with large numbers of Hispanic immigrants. She holds an M.A. in Sociology from the University of Virginia and a B.A. in Spanish, English, and Latin American and Iberian Studies from the University of Wisconsin-Madison.
